# 4. FIRST-AID MEASURES

#### **Necessary Measures:**

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a poison centre or physician. IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water. Wash contaminated clothing before reuse. Immediately call a poison centre or physician.

Because of the likelihood of corrosive effects on the gastrointestinal tract after ingestion , and the unlikelihood of systemic effects, attempts at evacuating the stomach via emesis induction or gastric lavage should be avoided. There is a remote possibility, however, that a nasogastric tube may be required for the reduction of severe distension due to gas formation.
