## 4. FIRST-AID MEASURES

**Necessary Measures:**

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a poison centre or physician.

IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water. Wash contaminated clothing before reuse. Immediately call a poison centre or physician.

IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a poison centre or physician.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. Immediately call a poison centre or physician.

Note to Physician: Direct contact with the eye is likely to cause corneal damage especially if not washed immediately. Careful ophthalmologic evaluation is recommended and possibility of local corticosteroid therapy should be considered. Because of the likelihood of corrosive effects on the gastrointestinal tract after ingestion, and the unlikelihood of systemic effects, attempts at evacuating the stomach via emesis induction or gastric lavage should be avoided. There is a remote possibility, however, that a nasogastric tube may be required for the reduction of severe distension due to gas formation.
